Hexagon Resources Limited (ASX: **HXG**) is pleased to advise that it has received an option exercise notice and funds in relation to 750,000 unlisted options.

On 3 March, 2015, US based investment fund, The Lind Partners LLC (**Lind**) was issued 3 million unlisted options exercisable at A\$0.16162 per share and expiring on 3 March, 2018 as part of a A\$1 million Convertible Note funding structure which was fully repaid.

The attached Appendix 3b relates to Lind choosing to exercise 750,000 of those options and Hexagon has received \$121,215 which it will utilise for its ongoing feasibility study.
