This is a notice given by Hexagon Energy Materials Limited (ACN 099 098 192) (**Hexagon**) in relation to the offer dated 16 February 2021 made under its off-market takeover bid to acquire all the ordinary shares in Ebony pursuant to its bidder's statement dated 16 February 2021 (**Bidder's Statement**).

For the purposes of section 650F of the *Corporations Act 2001* (Cth), Hexagon gives notice and declares that:

- (i) its Offer, and each contract resulting from acceptance of the Offer, is free from all the conditions set out in section 12.8 of the Bidder's Statement. Accordingly, the Offer is now unconditional; and
- (ii) as at the date of this notice, Hexagon's voting power in Ebony was 95.56% (comprising 111,508,357 shares out of a total 116,694,626 shares currently on issue in Ebony).
